Tour Costs:

Minimum Number of Participants →	15
Tour Cost Per Person Sharing a Double Room	\$3,396
Tour Cost Per Person in a Single Room	\$3,978

The tour costs do not include mandatory travel insurance, which is calculated as a percentage of the tour cost and the age of the traveler.

Age of Participant →	0-34	35-59	60-69	70-74	75+
Insurance Cost Percentage	3.94%	5.78%	8.06%	9.58%	13.42%

For example: If you are 65 years old sharing a double room, the cost of your insurance is calculated as $\$3,396 \times 8.06\% = \273.72 .

Included in the Tour Cost:

- Round trip from Davidson UMC to Charlotte Airport.
- Roundtrip flights from Charlotte on Lufthansa Airlines, including taxes and fuel surcharges.
- Hotels:
 - Feb 22 – Feb 25: 3 Nights [Maagan Eden Hotel](#) - Sea of Galilee (Standard rooms)
 - Feb 25 – Mar 02: 5 Nights [Prima Royale Hotel](#) Jerusalem (Standard rooms)
- Meals:
 - Full buffet breakfast and dinners daily at all hotels
 - 4 Lunches
- Bus, Touring and Transportation:
 - Private arrival and departure airport transfers in Israel
 - 6 Days of touring with a professional guide in Israel and 1 day in Palestine
 - 7 Days of bus services with a professional driver (Wi-Fi on the bus)
 - All entrance fees to sites visited and mentioned in the itinerary.

Not Included in the Tour Cost:

Generally speaking – Any service not mentioned above as included in the tour costs, is not included. This refers to: meals not mentioned, drinks during meals, touring or transportation outside of the itinerary, passports, visas, expenses of a personal nature such as gifts, minibar purchases, phone expenses and any other service not specifically mentioned above as included.



Tour Itinerary:

The tour includes seven full days of touring with lots of interesting and inspirational sites and experiences. The itinerary is subject to change over time, as we add or reduce certain activities. You will be provided the detailed itinerary about 2-3 months prior to departure. Some of the sites and experiences included in the tour costs are:

- The Sea of Galilee area and surrounding sites related to the life of Jesus.
- Sites in Jerusalem's Old and New areas, including the Church of the Holy Sepulcher, Via Dolorosa, Garden of Gethsemane and Yad Vashem Holocaust Memorial.
- Archeological sites such as Masada, Qumeran and Caesarea Philippi.
- Bethlehem, Shepherd's Field and the surrounding area in Palestine.
- Float in the Dead Sea, Boat ride on the Sea of Galilee, explore the markets and so much more!

Payment Schedule, Terms and Conditions:

- A. By paying any payments you signify that you represent the travel party and have read, understood and agree to these terms, conditions and disclaimer below.
- B. Payments are accepted by checks made payable to "Davidson UMC."
- C. **All payments are non-refundable by Davidson UMC.** In the event trip cancellation is due for a reason covered by travel insurance, you will be reimbursed through Travel Guard Group, Inc.

- D. Payment schedule:
 - a. **May 15, 2017:** Payment of \$300 deposit per person.
 - b. **July 15, 2017:** Payment of \$1700 per person.
 - c. **October 15, 2017:** Final payment is due (estimate: \$1700 per person)
- E. Rate Calculations:
 - a. Scopia LLC reserves the right to correct errors or omissions in calculations at any time.
 - b. All rates are subject to change without advance notice until final payment has been made.
- F. Others:
 - a. These terms and conditions are separate and different from any terms and conditions set by the airlines or other suppliers paid directly.

Travel Insurance:
